Victor Baratto, Retired Erie Community College professor



Victor Baratto, age 74, of Buffalo, NY died Wednesday, November 11, 2009.

A Buffalo native, Mr. Baratto studied to be an optician at Erie County Technical Institute. He served stateside in the Army as an optician for a couple years before returning to school to earn bachelor's and master's degrees.

As a licensed optician, he began teaching optical technology at Erie Community College in the early 1970s. Mr. Baratto retired in the late 1990's. During his 24 year tenure at ECC he touched the lives of many Ophthalmic Dispensing students.

Art Salas graduated from the Ophthalmic Dispensing Program at ECC in 1977. He worked at Opti – Vision in Syracuse, NY, Sterling Optical in Olean, NY and Cole National Optical (Sears Optical) in Buffalo, NY before heading out west. He attended the University of Arizona from 1985 – 1989 earning a Business Administration Degree while working at Santa Cruz Optical in Tucson.


In 1989, Art began working at Costco Wholesale and has been instrumental in bringing Costco's optical operation from the ground level it was at that point to the award winning business it is today. Currently, Art holds the title of Assistant Vice President for Costco Optical & Hearing Aids. Costco Optical is the 4th largest optical company in the U.S. with over \$500 million in sales while Costco Hearing Aids is the 6th largest retailer in the world with over \$100 million in sales – both under Art's control. He oversees the entire optical division which includes 700 employees, 392 locations and two state of the art laboratories. Costco Optical has been the recipient of the J.D. Powers and Associates Award as Best U.S. Optical Company three times in a row.

As an executive with Costco, Art has been involved in many of the charitable organizations that Costco works with. The United Way and Children's Miracle Network are just two of the many organizations that benefit from the millions of dollars donated annually by Costco.

Art and his wife, Terri, are strong supporters of the arts in the Seattle area. Art is also putting 3 needy students through college – one in Argentina and two in the U.S.

COA update Fall 2009

This past April the Commission held its semi-annual meeting in Durham, North Carolina. Among the items accomplished at the meeting:

Reaffirmation of accreditation was granted to:

The Ophthalmic Science program at Camden County College in Blackwood, NJ.

The Vision Care Technology program at Tyler Junior College in Tyler, TX.

The Ophthalmic Dispensing Program at TCI College of Technology, in New York City, NY.

The Commissioners congratulate the program directors and faculty on their excellent programs.

The *Essentials* for the Laboratory Certificate programs was reviewed and proposed changes are now available for comment by any interested parties. If you would like to review the proposed changes to this document, please contact me at Ellen@COAccreditation.com or at the address below.

A change was made to the *Essentials* for the Opticianry degree program to bring this document into compliance with a requirement of CHEA (Council for Higher Education Accreditation). This change requires that the accredited programs publish program outcomes. By September 21 all programs must report to the COA on how they are implementing this requirement.

The Commissioners reviewed the COA mission statement, and adopted the following: "The mission of the COA is to foster excellence in opticianry education by setting standards, assessing educational effectiveness, and identifying those academic programs that meet the standards, in order to aid programs to produce competent graduates who will provide professional services to the public." The Commissioners will be reviewing the goals and objectives at the fall meeting.

This fall there will be one reaffirmation of accreditation visit and one initial accreditation visit. During 2010 there will be four reaffirmation of accreditation visits.

The Commission continues with its application for recognition by CHEA (Council for Higher Education Accreditation). CHEA is now the organization of choice for accrediting agencies that do not need recognition by the US Department of Education for federal funding. Information about CHEA, including those regional and programmatic accrediting agencies that it recognizes, is available at http://CHEA.org. On November 21

Jayne Weinberger (Commission Chair) and I will be present before the CHEA Committee on Recognition to discuss the Commission's petition for recognition. In late December the Commission will be notified of the results of the hearing.

ABO/NCLE donated booth space to the Commission at their convention in Cincinnati, and I was there with information about the Commission for anyone with questions. The Commission raised \$860 in donations at the convention. Mike Goggin won a drawing for a \$250 gift certificate to Best Buy; the drawing was from the names of those who donated at least \$50 to the Commission at the convention.

PRESS RELEASE

Florence, Indiana; November 1, 2009

On October 24, 2009, the Commission on Opticianry Accreditation (COA) met in Durham, NC for the semi-annual business meeting.

The Commissioners reaffirmed the accreditation of the Miami-Dade College's Vision Care Technology/ Opticianry program in Miami, FL, and of the Southwestern Indian Polytechnic Institute's Vision Care Technology degree program and Optical Laboratory Technology certificate program in Albuquerque, NM.

During this meeting the Commissioners approved changes to the Degree *Essentials*, the Certificate *Essentials*, the Commission's Policies & Procedures, and the Accreditation Guide. The updated documents are all available on the Commission's website. The *Essentials* is the document containing all of the standards that a program must meet in order to be accredited by the COA.

At this business meeting the Commission's decision-making body was observed by a representative of the Council for Higher Education Accreditation (CHEA, http://CHEA.org). The CHEA Board of Directors has determined that the COA is eligible for recognition review by CHEA, a national advocate and institutional voice for self-regulation of academic quality through accreditation.

The Commission on Opticianry Accreditation (COA) accredits two-year opticianry degree programs and one-year ophthalmic laboratory technology certificate programs. There are ten members appointed by the NAO, OAA, and NFOS, plus two public members.

The Commission is a not-for-profit charity under the IRS rules for 501(c)(3) corporations. Donations to the COA are tax deductible. 
